Dasha is pursuing in legal studies while also serving as Vice President of the Taekwondo Athletes Council Canada and as Athlete Representative on the Taekwondo Canada's Board of Directors.

Anthony M. Wright (Vancouver, BC) is currently enrolled in a Juris Doctor degree at the University of Victoria. A former field hockey player, Olympian and coach, Anthony has held numerous athlete leadership, mentorship and advocacy positions, including as Athlete Ambassador for the Canadian Olympic Committee and ActNOW BC and as Board member of BC Athlete Voice.

Allan J. Sattin (Calgary, AB), who practices law as a civil litigator, has been an SDRCC Board member since May 2009. Allan has extensive experience in sport as black belt judoka, as chief instructor and coach of a local judo club, as internationally certified judo referee, and as member of the Board of Governors of Judo Canada
